6. Collections and acquisitions – Jane Philipps, coordinator

- 1. Review of acquisitions plan A. Chowdhury, History Discussion about books that should be in the collection/catalogue but are still not showing up. Perhaps we should think of a larger overhaul of the acquisitions plan. How is the plan distributed? Someone needs to go to the School of Business and devise an acquisitions plan. J.Philipps we examine this plan every 6 months. We need to be contacted once departments realize we are not getting what we should be getting.
- 2. Acquisition of electronic databases funding strategy for acquisition of New resources A. Chowdhury, History Discussion: Collections are shrinking; edatabases are expensive; is there a long-term expansion for this? It is great that there is a giant pool of money and that it is flexible, however, there appears to be no planning. You need a plan if the budget is to increase. Do you have a sense of what the budget will be in the upcoming years? M. Whitehead The new budget model provides a share of Faculty revenues to be devoted to library acquisitions and other university priorities, and there is an annual process to determine those amounts, starting with instructions for submissions around May of each year for

the next fiscal year. N. Soini – Liaison Librarians are more involved with purchasing and departmental representatives should work closely with their liaison librarians in regards to databases and collections and to communicate new research and teaching interests in their departments. J. Philipps – we are working on this, there is limited money and we are getting to the point where we cannot acquire new resources without cancelling existing ones. We have some trust funds, most with very specific terms of reference that can be used for the purchase of specialized resources. We do have collections policies in place with broad guide lines, we know what the core resources are.

3. New Resources – Elizabeth Gibson (LRS, Stauffer Library)

Vogue Archive The Library has purchased the The Vogue Archive, a complete searchable archive of American Vogue, from the first issue in 1892 to the current month, reproduced in high-resolution color page images. Every page, advertisement, cover and fold-out has been included.

IBIS World The Library now subscribes to IBIS World which is a collection of U.S. and global industry research. There is access to U.S. Industry Reports, U.S. Industry iExpert Summaries and Global Industry Reports. Covering over 700 industries, each report consists of 30-40 pages of key statistics and analysis on market characteristics, operating conditions, performance (current & forecast), competitive landscape and more. It is possible to search for industries by keyword(s) or browse a list of American industries defined according to the five-digit North American Industry Classification System (NAICS).

University of Chicago Press Journal Package QUL has acquired subscriptions to all of the UCP journals. The cost of acquiring the entire package was less than the cost to subscribe to individual titles as a result of discounting offered by the publisher. New titles to which we now have access include:
